



## INDIVIDUAL MEMBERSHIP TERMS AND CONDITIONS

As a registered individual member of APDA Ltd, you acknowledge and understand that you have the right to:

- Learn the APDA Ltd Syllabus.
- Attend classes at an APDA Ltd Member Club.
- Compete in any individual or team competitions (if applicable) organised by APDA Ltd.

### **Registration and Refund Policy:**

You understand that once your registration is complete, no refunds will be available.

### **Compliance with APDA Policies, Rules and Directives:**

You agree to abide by all current APDA Ltd Policies, Rules and any directives issued by APDA Ltd at any time.

### **Disclosure Policy:**

You understand APDA Ltd may use the personal information provided in your registration, as well as other information it obtained from you, to administer APDA Ltd business, its events, and competitions throughout Australia. This includes any activities in which you participate through APDA Ltd to care for and supervise activities in which you are involved. In some cases, this may require APDA Ltd to disclose the information to APDA Ltd affiliated clubs. In the event of a medical or child safeguarding issue arising, APDA Ltd may disclose certain information to doctors or other medical specialists and/or to police, children's social care, the courts, and/or probation officers, and potentially to legal and other advisers involved in an investigation as allowable under the Privacy Act 1988 and any other applicable legislation and/or laws.

### **Consent for Recordings and Photographs:**

APDA Ltd may, from time to time, record or take photographs at displays, competitions, and other events organised by APDA Ltd for the purpose of promoting APDA Ltd. These recordings or images may be used by APDA Ltd on its website, social media pages, advertising material, or in publications or mainstream media. As a registered member who participates in APDA Ltd events, you acknowledge that your image may be used by APDA Ltd for these purposes from time to time.

**APDA Ltd Insurance Cover**

You understand that APDA Ltd holds group insurance which is limited to professional, public, and management liability insurance only. This group insurance does not include personal accident/injury insurance.

As a registered APDA Ltd Individual Member, you understand and accept that your membership of APDA Ltd does not include Group Personal Accident Insurance and that you are not covered for personal accidents which may include injury, disability, or death whilst participating in APDA Ltd classes, performances, events, etc., arranged by APDA Ltd and/or APDA Ltd Member Clubs.

Individual APDA Ltd Member Clubs may hold additional insurance, including Personal Accident Insurance.

APDA Ltd advises all APDA Ltd Individual Members to confirm what insurance their APDA Ltd Member Club holds in addition to the APDA Ltd required Insurance Cover when registering as a member of the APDA Ltd Member Club. APDA Ltd Member Club registration is managed independently from APDA Ltd individual member registration, and APDA Ltd is not liable for any potential risk or associated claims relevant to insurances held separately by APDA Ltd Member Clubs outside of the APDA Ltd Group Insurance.
